(the "Land Trust"), the sum of \_\_\_\_\_ dollars (\$\_\_\_\_\_) in Canadian funds, which together with any capital gains earned thereon is referred to as "Original Capital", to be held in trust by the Land Trust as a ten year gift and, as such, an enduring property as defined under subsection 149.1(1) of the *Income Tax Act* (Canada), R.S.C. 1985, c. 1 ("Income Tax Act"), or by whatever term "enduring property" may be subsequently known as in the future, to be held for a period of at least ten years and with the specific terms of the trust to be those set out in the declaration of trust by the Land Trust dated \_\_\_\_\_ *[insert date applicable]* ("Declaration of Trust"), which established the Stewardship Endowment Fund, which terms include, as a minimum, that the Original Capital is to be held in trust and not disbursed, subject to such encroachment as may be permitted by the *Income Tax Act* (Canada), that the Original Capital shall be invested in accordance with the investment powers of the Land Trust in place from time to time, with the resulting income earned thereon, including interest income, dividend income, realized capital gains (as may be permitted by the *Income Tax Act* (Canada)), less costs, fees and expenses associated with the Fund, including such reasonable administrative fees charged by the Land Trust from time to time, to be available for disbursement purposes or for reinvestment in order to benefit and further the charitable purpose(s) set out in the Declaration of Trust as determined in the sole discretion of the board of directors of the Land Trust.
